SUBJECT: ELECTION RULES AND REGULATIONS

All candidates are expected to adhere to election rules and regulations as provided in the Murang'a University of Technology (MUTSO) constitution.

The electoral commission shall disqualify a candidate from election for any of the following offenses committed by the candidate or systematically carried out by his/her election team.

- a. Rigging.
- b. Use of violence or physical force.
- c. Intimidation and harassment.
- d. Use of vernacular languages in campaigns or use of other languages other than English and Swahili in the campaigns.
- e. Bribery.
- f. Giving false or malicious information.
- g. Questioning qualifications of other candidates.
- Mounting of campaign posters of any candidate in non-designated areas
- i. Verbal abuse.
- Use of foul language.
- k. Forgery of signatures e.g., in nominations.
- Slurs based on ethnicity, religion, gender, mode of study etc.
- m. Drunkenness and rowdiness.
- n. Unauthorized vehicles processions in and off campus.
- o. Non-adherence to campaign rules and timelines.
- p. Provocative attacks and incendiary attacks on the statutes, regulations and policies of the University.
- q. Defamation of any member of the University community.
- r. Receipt of funding from political parties, interest groups and probable.
