SUBJECT: DISSOLUTION OF THE 2025/2026 MUTSO EXECUTIVE COUNCIL

According to the MUTSO Constitution, Article VI, Section IV, Subsection i (g), it is the role of the Students Electoral Commission (SEC) to dissolve MUTSO Executive Council in preparation for elections after one year since it was elected.

In line with this, the MUTSO Executive Council is hereby dissolved and SEC declares the positions below vacant and open for contest. We therefore invite applications from contestants as per MUTSO Constitution, Article V, and Section 1.

1. Chairman
2. Vice Chairman
3. Secretary General
4. Treasurer

Special interests represented by three (3) elected members

5. Academic affairs, clubs and societies.
6. Catering and accommodation, gender, people living with disability and minority.
7. Sports, Games and Entertainment.
8. The two Mariira Campus Representatives

In addition to this, the electoral colleges will elect five (5) delegates per college (department) who will elect the MUTSO council on Election Day. **(Find the list of electoral colleges as posted by S.E.C)**

ELIGIBILITY FOR ELECTORAL OFFICES

- a) Candidates for the council shall be any registered member of the organization, other than students in the first year of study.
- b) Final year students are not eligible for nomination and election to any office.
- c) If elections are held in second semester first years may be eligible for delegates' positions only.
- d) Candidates for the council must be of good academic standing (with average of B and above for the undergraduate and a mastery score of 3 and above for the TVET students in the previous academic year examinations)
- e) Be of good standing in MUT and the society
- f) Must not have history of mental illness.
- g) Must not have served for two consecutive terms in any office in MUTSO council or any other University students' organization's council.
- h) No indisciplinary record.
- i) Candidates for the Delegates Electoral College are exempted from clauses (i) and (ii) below.
- j) Candidates for any position for MUTSO leadership must:
 - i. Have cleared fees for the current academic year by the time of nomination for undergraduate students.
 - ii. Have cleared fees for the current academic term by the time of nomination for TVET students.
- k) A party **MUST** constitute at least one member from TVET for the position in Council.
- l) A party **MUST NOT** present more than candidate from the same school for the position in the Council

The deadline for the submission of the council application forms is on Thursday 22nd January 2026 before 5:00pm.
